Old Hulmeians serving with H.M. Forces.

Since our last issue several Old Boys have been awarded Honours and we should like, in the name of the School, to offer them our congratulations.

Lieutenant-Colonel R. W. Lymer has been awarded the D.S.O. and the M.B.E., and has been appointed Assistant Quartermaster-General to the Eighth Army.

Lieutenant (Acting Captain) James Mark, Intelligence Corps, serving in the Middle East, has been awarded the M.B.E.. We have not, as yet, had any particulars of the good work that brought these honours, but we hope to have further information soon.

Squadron Leader T. G. Moore has gained the D.F.C., and we quote here the official citation from the Gazette: "As captain of aircraft this officer has taken part in many operational sorties, including attacks on Berlin, Hamburg, and the Ruhr valley. Throughout he has shown great devotion to duty, and his cheerful spirit in the face of difficulties has been an inspiration to all."

In December we spoke of the award of the D.F.C. to Pilot Officer W. C. Walton, but at the time we were without the full particulars. The London Gazette of 4th December, 1942, says: "Since July,

1942, this officer has destroyed at least four enemy aircraft and damaged others. One day, in October, 1942, when he was flying with the squadron, a formation of six enemy bombers, escorted by twenty fighters, was sighted approaching Malta, immediately attacked the bombers and they broke away. By skilful manœuvring Pilot Officer Walton made a head-on attack on one Junkers 88, which he destroyed. During a period of intense aerial activity over Malta large enemy formations frequently attempted to attack the island. On many occasions this officer, by his skilful interception, forced the enemy bombers to turn back before releasing their bombs. Pilot Officer Walton has displayed conspicuous gallantry, and his fearlessness and fine fighting spirit have been exemplary."

War Victims among Old Hulmeians.

For some time past certain members of the Old Hulmeians Association have considered it very unlikely that the present war will pass without at least a few cases of very acute distress among the dependants of serving Old Boys: Indeed, we may consider ourselves fortunate as a body that such cases have not already arisen in considerable numbers. One need hardly go into details, but imagination readily conjures up the state of, say, a widow with older children to clothe, to feed and to educate who is left entirely dependant upon the tardy parsimony of the Ministry of Pensions. When more active European warfare commences again such possibilities will become daily more probable.

During the last summer the General Committee of the Association enquired into the possibility of accumulating a fund to help to meet any such cases of sudden and severe distress in the families of our serving members. Messrs. C. H. Jones, D. M. Williams and D. Ll. Griffiths were appointed as a sub-committee of the Association, and they presented a report dealing with the possibilities of raising money for this purpose. It was, however, decided that the launching of a fund of this nature is not an activity upon which the Association as such can enter unless a General Meeting should consent.

As a representative General Meeting is manifestly impossible at present, the members of the sub-committee have decided, acting purely unofficially and as private individuals, to see what response can be made to an appeal to the readers of "The Hulmeian" to support a scheme with the object of accumulating money for this purpose. In the first instance money is not being asked. No cases of dire financial need have as yet arisen amongst us as a result of the war. It is desired to anticipate the occurrences of such cases by collecting promises of sums of money, part or all of which promises will be called upon when a case or cases arise.

This scheme is not attempting anything big. Readers are, however, reminded how, after the fall of Singapore, long intervals were apt to occur between the death or capture of a soldier and the award of a pension or grant to his dependants. Such circumstances, which may well be repeated when the casualty lists begin to mount, were often accompanied by hardship so acute that the immediate grant of even twenty-five pounds from some fund which could act quickly would have made an incalculable difference. Fortunately, our own circle was spared distress of that degree, but it would be fantastic to pretend that we shall always be so immune.

Details of the administration of the scheme can hardly be entered into here and now. Cases will have to be considered on their own merits as they occur. Let us, however, realise that the preparation of such a scheme is urgent, and that it is our duty as Old Boys of the School to do our best to be prepared to soften a cruel and sudden hardship with the ready and rapid help which only a private fund can give.

Promises, which should be as large as possible, should be addressed to Mr. D. M. Williams at the School and, as already stated, money will not be called for until it is really needed.

The Old Hulmeians Lacrosse.

We concluded last year's matches with an excellent game on Boxing Day on our ground against Manchester University. This match was not on the fixture list, but we had no difficulty in raising a team, and it showed us that all are keen to play in spite of these difficult times. Unfortunately, our first match this year on January 9th, against the Old Mancunians, was cancelled owing to the unsuitable condition of the ground.

With this exception the playing conditions have been good, and, as all but two of our matches have been played at home, this has proved most helpful. At the time of writing we have played nine matches, of which we have won six and lost three.

We have had more players called to the Forces, but we have been fortunate enough on occasions to have at our disposal more players than we required. We have not had any new members, but this is not surprising as the lowering of the "calling up" age has now left a very small margin of time for boys to play after leaving School.

We have had J. Buckland on leave on three occasions this year, and his attack play greatly strengthened our team.

- A. W. Orr, who was unable to play for us at the beginning of this season, made a very welcome return to the side at the commencement of this year.
- N. R. Coe has captained the side and has led the attack, being well backed up by S. Gill and P. Flinn. H. Milgate, also on the attack, has played some good games.

Oxford Old Hulmeians.

This term we have had some exceptionally fine weather, and this has encouraged outdoor activities. A crowd of several thousand watched the boat race against Cambridge, which was rowed at Radley, near Oxford. It was very different from the prewar event, the course being only a mile and a quarter long; also, as it was rowed downstream and the race lasted only a little over four minutes. Oxford gained the lead at the start, and held it all the way.

Cambridge was also met at rugger, soccer, hockey and athletics, and Oxford managed to win all except the rugger.

The first Naval Cadets for the short course came up to Oxford this term; they combine training under the O.U. Naval Division with University work, in a similar manner to the R.A.F. and Army Cadets at this and other Universities. They will help to keep the Universities going in the dark days ahead when no "arts" students will be allowed to come up.

- D. R. Wood is taking his clinical course at the Radcliffe Infirmary, and shifting his "digs" periodically. He plays rugger for the Oxford Medicals; among their fixtures they met the Cambridge Medicals during the term.
- G. A. Weeks is still doing research in Chemistry, but is already thinking about a job, for he goes down at the end of the summer term.
- J. D. Robson continues his Engineering course with the prospect of Finals at the end of next term. This and rugger seem to take up most of his time, though he sometimes finds time for a game of squash.

- S. S. Wilson has joined the University Yacht Club and spends most suitable afternoons sailing the Club's 12-foot racing dinghies on a reach of the River Thames. He has even persuaded other O.H.'s to accompany him, at great risk, but they seem to enjoy it.
- B. P. Topley continues his mathematical studies, but finds that he will be unable to take the full course of two years in Engineering as he had intended. Instead, he may go down after one year and return after the war to complete his work.

Cambridge Old Hulmeians.

Nothing of great, note has occurred this term, though everyone seems to have been very busy; S.T.C. duties, fire-watching, sport and a certain amount of work leave us all with little spare time. At the end of this term D. S. Hewet (Peterhouse) has to stay up for an extra two weeks to do S.T.C. work; at the end of the fortnight's course he is due to take his Certificate "B," J. O. Spalding (Jesus) and G. B. Warburton (Peterhouse) have to go up a week early next term in order to take a course of intensive training. All three have been putting in two four-hour parades a week during this term; Hewet of the Infantry unit regularly crawls miles through the ditches of Cambridge, while Spalding of the R.A. unit specialises in pushing a 25-pounder gun through the muddiest fields in Cambridge; Warburton of the R.E. unit is to be seen erecting bridges or else calculating how many gun-cotton slabs it would take to blow up the various bridges on the Cam.

The most notable sporting achievement is that Spalding rowed for Jesus First Boat in the Lents. Previous to the races he had spent a great deal of time on the river putting in the necessary practice. Hewet has also spent a good deal of time on the river this term, though it is doubted whether his activities have been as strenuous as those of Spalding. Warburton has played rugger for Peterhouse

on several occasions, but the necessity of attending the Engineering Laboratories to do a little work has prevented him from playing more frequently.

Despite the war the social activities of Cambridge earry on, and, although due to the war no formal meetings of the Cambridge Old Hulmeians Association have been held, informal meetings, ostensibly for the purpose of lunching or having afternoon tea, are frequent.

The Entertainments.

Encouraged by the success of last year's experiment in resuming our Tuesday afternoon entertainments in spite of war-time difficulties, another series was given this term, the first play taking place on February 22nd. Before this, however, we had ventured on a Christmas entertainment, when successful performances were given on the afternoons of Friday and Saturday, December 18th and 19th.

Early in the Midsummer term we are to have performances of "Captain Brassbound" (Shaw) and a Concert, the dates for which have yet to be fixed.

Programme:

Plays.—On Friday and Saturday, December 18th and 19th, performances of "Trial by Jury" (Gilbert and Sullivan), "Any Body" (Gordon Whitehead), and "Fat King Melon" (A. P. Herbert) were given by the School. A report will be found on another page.

Play,-February 22nd. "A Cash Concern" was presented by VI. C.M.L. This one-act play is simple in construction and undistinguished in dialogue, but very earnest in its efforts to amuse. It concerns the attempt of two schoolboys, William (J. W. N. Glover) and Timothy (T. Lawrence) to obtain extra pocket-money by setting up a hat-shop at their home, whilst their mother is in a nursinghome. The consequent complications are not very original, nor are they as amusing as intended. The entrance of Mrs. Sykes whilst the boys and others are engaged in much dressing up and scuffling is an expected surprise. The best performance was given by F. A. Stone as Miss Murgatroyd; he was convincing in the most undignified circumstances. Otherwise the acting was patchy, although G. Lees was quite successful in the part of Mrs. Sykes. One feels that the talents of Mr. Parren and VI. C.M.L. could have been more worthily employed than in this piece, whose best "line" was obviously a topical interpolation by the producer. Other parts:— Simpson Senior-D. Gibson; Marmaduke-G. A. Anderson; Tomkins-P. B. Wightman.

Lecture.-March 2nd. The subject was "Lacrosse" and the lecturer was Mr. Barber. One would have thought that there was comparatively little to be learnt about a game so young as lacrosse, but Mr. Barber's talk, which began with a short history of the game, was instructive to novice and adept alike. An excellently drawn plan of the lacrosse field did not tempt Mr. Barber to embark upon a dull exposition of the rules. His talk was rather a collection of hints on play and on the care of the 'crosse (so called because of its resemblance to a bishop's crozier). Perhaps even the members of the 1st team learnt something from this lecture.

Play.— March 9th. "Unhampered," by Ronald Mackenzie, was played by IV. B. Plays about schools are numerous, and some are good, but surely none other can claim to have included in its structure "a detective story in blank verse." The first and third acts are conventional, but the second act sometimes attains unexpected heights of burlesque. A. Wilson (Dickenson), N. I. Cross (Cranbury), and I. A. Carter (Higgins) made adequate schoolboys, but as John Darton, Lord Eustace Maltravers, and Sir Desmond Huntingdon respectively they were much better. (Apparently the players found it easier to over-act than to act.) Perhaps the most natural performance came from H. R. Crewdson as Fortescue, the small boy with literary inclinations. Other notable points were I. A. Carter's excellent immobility as the dead Higgins, and a remarkable scream by M. R. M. Frayling (Joanna Huntingdon). Other parts: Lady Huntingdon (A. Salmon), The Cook (P. S. Boswarva), The Butler (B. D. Etchells), Sleuthund Seeker (R. A. Herz), Housemaster (J. Timmins), Play produced by Mr. Thompson.

Play.—March 16th. On this occasion III, B held the stage with "The Rose and the Ring" (Thackeray, arranged by E. E. Olson). By now, plays about kings and princes and fairies and magic are common occurrences on our stage, and this familiar one is as entertaining as any. It is in three scenes, and some of the chief characters possibly found its length rather tiring. But the acting was generally good, and enthusiasm was not lacking. P. Milgate played Valoroso XXIV., King of Paflagonia, and although in this part he was not quite as merry a monarch as in a former play, he acted intelligently and amusingly. A. Morley was a charming Fairy Black-stick, and R. Thompson (Princess Angelica) and J. J. Nesbitt (Betsinda, otherwise Rosalba) looked surprisingly feminine. A. Wilkinson (Prince Giglio) and D. A. Play.-March 23rd. This compact little thriller, "Shivering Shocks," by Clemence Dane, was well presented by 3A, and its complications were not made obscure by indecisive acting. The business of the secret formula and "a foreign power" is indeed topical to-day. P. Salt was most effective as Captain Dallas, V.C., D.S.O.; B. A. Maguire (Granville Hughes, B.Sc.) seemed a sufficiently agitated scientist, although his short-windedness was almost too convincing. B. T. Gibson as "Rowley" assumed what must surely be the best Cockney accent produced by a member of the Junior School for some time; he was also excellent in other respects, except for a slight surfeit of staggering. "The Shepherd" (D. Ogden) was a simple but very wicked crook. Kysh the butler, and Dawson were played by A. M. Bell and D. M. Schlapp respectively. The play was produced by Miss Green.

"TRIAL BY JURY."

It is several years since an opera of any kind was presented on the School stage, and one would have thought that the divers difficulties of rehearsal and production would prove insuperable at the present time. But the industry and enthusiasm of performers, orchestra and producer were, on this occasion, suitably rewarded by the sincere appreciation shown by the audience.

"Trial by Jury," brief though it is, demonstrates admirably the blending of verbal and musical excellence which is typical of the Gilbert and Sullivan partnership, and in Mr. Parren's production neither melody nor wit was neglected in favour of the other. The orchestra, under the direction of Mr. Williams, rendered, more than adequately, the lilting pleasantness of the music, and never became strident in the more dramatic passages. The singers tried, without exception, to give Gilbert's words their full value without obscuring the tune. The Headmaster took the part of the Learned Judge (and, as Gilbert says, "a good judge too"); he sang well, and with all the humour which the part demands. G. E. Marsden, as the Defendant, was pleasant in voice and in bearing, and so, too, was F. S. Sutcliffe as the Plaintiff, although the latter's voice is, unfortunately, not possessed of great carrying quality. The Counsel for the Plaintiff (D. Gibson) was tuneful and restrained, and the Usher (P. B. Wightman) showed a good sense of comedy. A W. Peers was the worthy Foreman of a jury of u. paralleled unanimity. In song and gesture these gentlemen were indeed The Bridesmaids, too, were decorative excellent.

and disciplined, and the large chorus, although often a little untidy, convinced us of their interest in the case before the court.

The whole wardrobe was supervised, and the Bridesmaid's dresses were cleverly designed by Miss Denton and Miss Slater.

"ANY BODY,"

"Any Body," by Gordon Whitehead, is not a great one-act play, and it suffers from an unsatisfying climax. But, as produced by Mr. Brierley and as acted by a clever and vigorous cast, it made very good entertainment. Mr. Brierley, as Bond, an expansive and amusing publican, gave a polished performance; he was well supported by Tom (E. Collier), who made the best possible use of his comic ability, in spite of a tendency to over-act. Mr. X. (G. S. Hall) was an angularly mysterious, if somewhat subdued, stranger. J. C. White, as P. C. Tapp, was delightfully inefficient, and Bate, the postman (M. Broady) strode effectively upon his official errand. G. D. Hansom contributed a realistic study of an old man reluctant to leave a public-house, and P. H. Richards, P. Grantham, D. Watkinson, and J. B. Roberts were convincing villagers.

On the whole, the players, although handicapped by a slight and improbable plot, were completely successful in causing us to wonder with apprehension what Mr. X.'s sinister suitcase contained.

"FAT KING MELON."

This familiar piece by A. P. Herbert, with incidental music arranged by Dennis Arundell, is described as "a drama in five scenes." Apart from an appropriately loutish company of soldiers and sailors (D. Gibson, P. S. Hewitt, T. Lawrence, G. E. Marsden, G. W. McGuffie, D. K. Partington, A. W. Peers and P. B. Wightman), the play was acted entirely by juniors, all of whom were confident and audible. The five scenes are linked by a Prologue, who was excellently played by D. A. Ginever. B. T. Gibson, as Fairy Mumbo, spoke his curiously un-childlike lines well, and A. Morley was an irresistible Fairy Giggle. P. Milgate, who appears to make a speciality of pompous imaginary monarchs, again acted intelligently, and Princess Caraway (J. P. Chilton) was competent, both when slim and when plump. The King's mother (P. Salt) was amusingly majestic, and D. Ogden played the Highwayman's part with sufficient abandon. Other characters were: Greengage (W. D. Cheadle), A Deaf Old Woman (G.
