

#### Editorial.

THE past term has been a very sad one for the School. Mr. Adams, who had been with us as Science Master since 1887, died after a short illness on Sunday, March 8th. Three weeks previously to this he caught a severe cold; and there is little doubt that a characteristic desire not to give up work, so long as his health lasted, led him to overtax his strength, and on February 26th, he was laid up with an attack of pneumonia which ended in his death. Of Mr. Adams's life and work at the School we need say but little; few who came in contact with him could fail to recognize the zeal with which he entered upon all that he did; or to feel that by his death we have lost one whose influence and example were always on the side of good.

In our last number we had occasion to prophesy a further development of the Old Boys' Club, and we are glad to find that our expectations were not too sanguine. We publish below an account of their Football Season; in the next number we shall also be able to record their doings in the Cricket Field. A Cricket Club has been successfully formed; and though somewhat limited in numbers—a defect which time will of course remedy—the quality of its playing members is such as to augur well for its success.

On the prospects of the School in Cricket this summer it is too early to pass judgment. It will not be easy to supply the place of several of last year's eleven; in bowling especially we are likely to be weak. But it is well to remember that constant and careful practice is the one secret of success in bowling as well as batting; and we would, therefore, advise our bowlers to be more regular in their attendance at the nets, than they have been during the first fortnight's practice.

### Old Bulmeians' Club.

MEETING of Old Boys was held at the School, on the 21st February, in order to consider the possibility and advisability of forming an Old Hulmeians' Cricket Club for the coming season. The attendance of Old Boys was not large, only 16 being present. The Head Master, who was in the chair, having explained the object of the meeting, a resolution was unanimously passed that it was most desirable to form a Cricket Club this season, in order to secure the services of several Old Boys who would, otherwise, probably join other clubs. The next subject discussed was the the important one of ways and means. It was considered that at least £40 would be required to pay the expenses of the club this season. The hiring of a field would cost £20; £10 would be required for materials, and that would leave fio for current expenses. The next question was the raising of the money, for, fixing the subscriptions of playing members at 10/6, the revenue derived therefrom could hardly be expected to produce more than from £15 to £20. The Chairman having generously offered to subscribe in case of need any amount up to £10; it was resolved to appeal for support to the parents of boys at present in the School, and the following circular letter was therefore sent out:-

DEAR SIR,

I am instructed by the committee of the Old Hulmeians' Cricket Club to write to you to ask for your support to the Club, in this, the first year of its existence.

Our reasons for appealing to the parents of boys at present at the school are that (i) the expenses of starting the club are necessarily heavy; (ii) in order to give every old boy the opportunity of joining we have fixed the subscription for playing members at a moderate sum; (iii) the number of old boys being at present very limited the club can hardly be expected to be self-supporting; (iv) it is important to start the club at once; otherwise we shall lose many of those who will shortly become its most efficient supporters; (v) your own sons will, in a few years, reap the benefit of our present efforts

#### Old Hulmeians' A. F. C.

Continued from HULMEIAN of December, 1890.

After the Woodford match of December 6th, no Football was possible, owing to the severe weather, until February 7th, 1891, when the return match with the School was brought off, and after a hard

fought game we were victorious for the first time by two to one.

The Catholic Collegiate Institute were met on February 14th, but owing to the inexcusable non-appearance of three of our team, the game partook more of the nature of a sides game, and we of course came off second best to the tune of five goals to one.

On February 21st, the Club played St. James's A.F.C. on their ground at Alexandra Park. This game was perhaps the most stubbornly fought of the whole season, both sides having very hard lines in not scoring several times. Twice the St. James's cross-bar was hit by shots from Corbett and Hart, and but for the brilliant goal keeping of Moffat and the St. James's custodian, the score of one to nil in their favour would have been very much exceeded on both sides.

February 28th and March 7th were devoted to "A" team matches, with Shrewsbury Olympic, and Princess Road Football Clubs respectively, the former ending in a draw of two goals each, and the latter in a win for us by three goals to two.

Our return fixtures with Stamford A.F.C., which had been postponed before by reason of the frost, was cancelled in March on account of Mr. Adams's death. The return match with Woodford A.F.C. on March 21st concluded our list of matches. Though unable to wipe off the defeat we suffered at their hands in November, we nevertheless succeeded in bringing our first Football Season to a close with a draw of three goals each.

In reviewing the season we find that twelve matches have been played, of which five have been lost, three won, and four drawn. This is not an altogether satisfactory record; but it must be remembered that we were very late in arranging our fixture card, and consequently were limited in our choice of matches; while the loss of much needed practice during the frost was especially disastrous to the prospects of a newly formed club.

Next year we look forward confidently to a prosperous season, and if the committee can gather together sufficient members to form a Second Team, the success of the club will be guaranteed.

Below is the Treasurer's statement of accounts, by which it will be seen that we are indebted to the kindness of two or three gentlemen for our satisfactory financial condition.

It should be mentioned that the election of the Captain and Vice-Captain of Cricket involved a constitutional difficulty. A resolution had been passed, more than a year ago, to the effect that it was then inexpedient for the same boy to be Captain of more than one game. On the present occasion, however, the Committee decided to suspend this resolution, with the result that Shorrocks, E., became eligible for the office of Captain of Cricket, in spite of his having held the Captaincy of Football.

Meetings have been held every week during the Term for the transaction of ordinary business, and it is satisfactory to note that the attendance of Members continues to be good.

#### School Concert.

The second School Concert was given on the afternoon of December 18th, the day before our school broke up for the Christmas holidays. The Central Hall was well filled with an appreciative audience of parents and friends of the performers. while the gallery was reserved for members of the school whose approbation more than once approached enthusiasm. As at the first School Concert the programme was made up chiefly of glees and part songs practised by the School Choir, which was conducted, for the last time, by Mr. Badham, and did full justice to his painstaking and thorough training. Rossini's lively "Carnovale," given with much spirit and abandon, was perhaps the most successful of the performances of the choir. Songs sung by Mr. Joseland, Shorrocks, Corbett and Hallett; violin solos by Bardsley and Ashworth; and the pianoforte playing of Baker and Bateman all received well-deserved applause, while for Mr. Urwick's recitation a clamorous encore was not accepted. We owe our thanks to Mr Joseland and Mr. Bally, of the Manchester Grammar School, for kind and valuable assistance in the part songs.

The first object of our School Concerts is to give parents and others interested in the school, an opportunity of seeing or rather hearing the results of the musical part of our school teaching, which concerns itself simply with vocal music. At the same time we are glad to avail ourselves on such occasions of whatever talent for instrumental music we possess, although it is only indirectly that such talent reflects credit on the school. During the preparation for the concert, a host of budding pianists and violinists were discovered, some of whom we may hope to hear at School Concerts of the future. The Programme was as follows:—

GOD SAVE THE QUEEN.

After the detailed account and criticism of our doings in the Football field, during the Christmas Term, which has already appeared in the Hulmeian, it is hardly necessary in the present number to do more than summarise the final results of the season. We played, in all, fifteen First Team matches, out of the twenty-two which were put down in the Fixture Card. Of these we won six, lost seven, and drew two, scoring altogether twenty-five goals, against an adverse total of twenty-nine. But, though these figures are far from satisfactory, they must not be taken as data on which to form an estimate of our team. Two of the matches playedthose against the General Post Office-cannot properly be called School Matches. In the second we did not pretend to play more than an "A" team, for we were engaged in a first team Lacrosse Match on the same day; and in both the weather was of a decidedly anti-football character. But after making all allowances, it must be confessed that we were weak last Term, much weaker than the term before. We lost the services of Baker, Thrustle, and Rickitt, and the Captain was compelled to rearrange, or rather to dis-arrange the team, in order to fill the vacancies. The change which most affected us was the loss of an excellent goal-keeper in Bennett, who had to be requisitioned as a forward; and though Barrett and Ward Jones, especially the latter, both played well, they were hardly equal to Baker and Thrustle. Of the old members of the team, Shorrocks played as well as ever, and Bennett proved very useful to the forward division, especially on account of his pace. The half-backs, Sclater, Classen, and Norbury played pluckily and well, but were often outmatched in speed by their opponents. Saxelby, at back, played better on the whole than during the Christmas Term, but was still rather slow in getting to the ball, and at times missed his kick badly. Holroyd played with plenty of energy and kicked well; but neither of the backs were ready enough to run back for the defence of goal, where our chie weakness lay.

The result of this game was most unexpected by all the members of the School Eleven. The play was of a very even character throughout, our opponents having perhaps the best of it. brought up only ro men, and as a substitute was not accepted, played that number during the game. The solitary goal obtained was the result of a beautiful piece of play between Booth and Baker, the pair taking the ball right down the field, when Booth centred and enabled Baker to put it through. Our opponents had very hard lines once or twice, especially when the forward mentioned above stumbled and handled the ball when just in the act of shooting. Saxelby's play at back, especially during the second half, is worthy of praise. Final score-one goal to none in
