The Library.

It has been rather a disappointing term as regards additions to the Library: the most outstanding have been Chaucer and Spenser Handbooks and an Algebra for the use of Higher Forms. Mr. R. Astin, O.H., has, however, very kindly presented some thirty books, the most useful being an International University Course in five volumes. We have to thank Mr. Charles H. Barber for fourteen volumes of the "Art Journal."

It would be much appreciated if those using the Library would return books as quickly as possible, since many books are in great demand, and duplicate copies are practically unobtainable.

This term has also seen the appointment of J. F. Wyatt as Assistant Librarian. G. V. C.

The Debating Society.

There have been only three debates since the end of last term owing to cricket practices and the approaching examinations. We hope, however, to have many interesting meetings next year.

On March 15th we held a political debate on the motion that "A return of the Conservative Government is to be deprecated." A. B. Wilkinson and R.

Calderwood, proposers of the motion, not only showed that the Conservatives have no plan for the future, but also suggested a Labour Government in its stead. The Opposition, led by G. V. Chivers and F. P. Carson, gave the Conservative policy in full and deprecated unwise controls. Some of the House did not approve of either political party, and determined to abstain from voting. The motion was defeated by twelve votes to five, with fourteen abstentions.

At the next meeting, on April 19th, we copied another House and debated the motion that "The House considers Capital Punishment should be abolished." V. Edkins and A. B. Wilkinson not only gave the moral reasons for the abolition, but offered examples of countries which had abolished the supreme penalty and benefited greatly by so doing. P. W. Walker and R. W. Douglas argued that it was a duty to the welfare of the State to retain the death penalty. Much interest was added to the debate by the intervention of Mr. A. Cartwright, O.H., who had served for many years with the Indian Police Force. This motion was carried by fifteen votes to five.

On May 10th a joint debate was held with the Scientific Society to discuss whether "The Philosopher is a greater benefactor of the human race than the Scientist." B. T. Gibson and E. Bowcott, the proposers, stated that the philosopher helped man to achieve a full development of his ideas and to establish a supremacy of the mind rather than of the body. The Opposition, led by V. Edkins and J. J. Nesbitt, argued that the scientist was offering man perfection and truth in both body and mind. The close alliance of Science and Philosophy was realised by both parties. The motion was defeated by eleven votes to nine.

These last two debates were most interesting, and augur well for the future.

The Scientific Society.

The Scientific Society was inaugurated on the 18h of March, 1948, under the presidency of Mr. Whatton, who stated that the first business of the Society was the election of a chairman, a general secretary and a minutes secretary. Votes were then cast at the following elected: As chairman, B. G. Allen; general secretary, J. G. King; and as minutes secretary, F. D. Bimister. A post of deputy-chairman was created, and J. W. Steer elected to the post. Was arranged that meetings and lectures would held on the Tuesday of each week whenever possible and that (due to the more advanced nature of the topics chosen by lecturers) the audiences would have

to be members of the Upper and Lower Sixth Forms, and occasionally members of the Fifth Forms.

On the 22nd of March Mr. A. H. Barrington, a member of the Stretford and District Gas Board technical staff, gave a lecture on "Coal and its Bytechnical staff, gave a lecture on "Coal and its Bytechnical staff, which, unforproducts," illustrated with two films, which, unfortunately, were not seen at their best, due to the fact that the School Hall could not be adequately darkened, but our thanks are due to Mr. Barrington for the trouble he took in preparing and presenting the lecture.

On the 13th of April Mr. Wharton gave a lecture on "The Scientist in Industry," and the lecture was given with what was obviously practical experience of the administration of a large works.

D. M. Schlapp gave a lecture on "Valves" on the 20th of April, twenty members attending.

On the 27th of April J. G. King gave an excellent lecture on "The Cathode Ray Tube," with many demonstrations with the School "oscilloscope" and X-ray tube, and many questions of interest were asked after the lecture.

On the following Tuesday a lecture on "Television" was given by the chairman, B. G. Allen; fourteen members attended.

As the Higher School Certificate Examinations drew near the Society meetings came to a close for the Midsummer Term, but visits to works have been arranged to British Electricity House, East Didsbury, on July 14th, to Metropolitan-Vickers Electricity Department on July 16th, and to the Imperial Chemical Industries, Blackley, on July 21st.

FIRST XI.

We started the season with seven of last year's colours, and as there was promising material from the Second and Colts, we had hopes of a successful season. These hopes have not quite been fulfilled, as, though so far we have lost only one match, we have won only three. In each of the drawn games we have been in a strong position, but have been unable to press home our advantage.

The batting is strong. In only one game have we failed to make a reasonable score, and we have been all out only twice. The fault most difficult to eradicate is a tendency to bring up the right foot when playing forward. In addition to the obvious danger of being stumped, this causes the body to turn to the left, and pulls the bat away from the line of the ball. Many of the team have good scoring shots, but we have not always been able to score quickly enough on the slow wickets which have been usual this season.

The bowling is varied and enterprising. Godson and Smith, both of whom are faster than the average school bowler, have taken most of the wickets. Blight, with well-flighted leg-breaks, Cuthbert, whose left-hand spin is improving, and Lawson have been effective changes.

The fielding has generally been sound, and sometimes very good, but there have been occasional lapses, and, as is usually the case, some of these have occurred at critical moments.

Threlfall has captained a keen team well, and has used his bowlers most intelligently.

Against Manchester C.C., at Old Trafford, we made our best score for many years, and our opponents were only saved by a characteristic innings by Makepeace. In an exciting finish we defeated Cheadle Royal for the first time for three years, and have won a convincing victory over a strong Old Hulmeians team. We collapsed badly on a difficult wicket at Manchester Grammar School, adding to our difficulties by some wild hitting and two stupid run-outs. Our total of 27 gave us little chance of victory, but we fought back to such purpose that they lost six wickets in getting the runs, and were themselves all out for 40.

Saturday, May 29th, v. King Edward VII. School, Lytham. Away. Match drawn.

This match, which was limited to 3½ hours' play, was a rather depressing start to the season. Against some unsteady bowling we scored at a fairly rapid rate, and, thanks chiefly to Godson and Ward, we were able to declare with two hours left for play.

Professor H. J. Seddon has been appointed Director of Studies of the Institute of Orthopædics, and Clinical Director of the Royal National Orthopædic Hospital, London.

We are grateful to the Editor of The Lancet for kindly permitting us to reprint the following account of his career:—

Professor Seddon, who is 44 years of age, was educated at Hulme Grammar School, Manchester, and St. Bartholomew's Hospital. He was awarded the gold medal when he took his M.B. in 1925, and

in the same year he took the F.R.C.S. While holding house appointments at Barts. he was also for a time registrar at the Royal National Orthopædic Hospital. In 1930 he was appointed to an instructorship in surgery at Ann Arbor, Michigan, under Professor Hugh Cabot and Dr. Vernon Hart. The following year he returned to Barts. as chief assistant in the orthopædic department, and a few months later he became resident surgeon at the Stanmore branch of the Royal National Orthopædic Hospital, where he held demonstrations and supplementary classes in orthopædics for the students from four London hospitals. In 1940 Mr. Seddon was appointed to the Nuffield Chair of Orthopædic Surgery in the University of Oxford, and received the degree of D.M. He also became surgeon to the Wingfield Morris Hospital. In 1943 he had won the Robert Jones gold medal of the British Orthopædic Association for his essay on "Pott's Paraplegia," and in 1935 he had delivered a Hunterian lecture on "Caries of the Thoracic Spine." During the war his published work dealt chiefly with the surgery of nerve injuries. In 1943 and 1945 he visited Malta and Mauritius at the request of the Colonial Secretary to advise on the outbreaks of poliomyelitis, and he is a member of the Colonial Medical Advisory Committee. He was also a member of the Ministry of Pensions Departmental Committee on Artificial Limbs (1944-45).

In the evening the Hampstead and Hampton Court Clubs entertained us, most properly, to dinner at "Chez Auguste," where the menu appropriately started with "Hors d'œuvres à la Crosse." On the Saturday we had an easier win by 15-4 at Addiscombe, against Purley, who later entertained us, not so properly, but very hospitably, and presented us with a trophy, suitably inscribed, for, it is hoped, annual competition. The evening was notable for the inauguration of the club's theme song "Only a bird in a golden cage," persistently sung by our recently returned "sahib," and the rodeo prowess inspired in another of our members by Cambridge's boat race win. Sunday was a rest for most and on Monday morning we showed our best form of the tour against an Old Dunstonian's team at Beckenham Hill. That our hosts took our 19-3 win in good part was confirmed by the generous manner in which we were fed and "watered" before our departure, most surprisingly as a complete party, for Manchester, which we reached late, but with pleasant memories of a most successful tour. Old Hulmeians Rugby.

We hope to open the coming season there, but if this is not possible we shall continue for a short time at Yew Tree Lane, Northenden.

The Association offered to parents who had recently moved into the district an opportunity of making social contacts they might otherwise find difficult to discover. By meetings and discussion parents could iron out personal difficulties, and would

develop, through a community of interests, a personal concern in all the activities of the School, and so they would not regard it as merely the place when their sons happened to be educated.

Proceeding to other matters, Mr. Bird announced his intention to extend the Housemaster system, and explained the advantages he expected to be derived therefrom. Arrangements were being made to hold a School Confirmation next term, and the Head master invited parents who wished their boys to be confirmed to write to him before the end of term so that the necessary arrangements could be made. The Chairman warmly thanked Mr. Bird for his attendance and address.

The Secretary submitted the Committee's report for the year, which was accepted, as were the report of the Social and Lectures Sub-Committees, submitted respectively by Mr. Price and Dr. Littler. Detailed consideration was given to the new Constitution, as printed and circulated by the Committee, which was accepted with a few minor amendments. Copies of the new Constitution will be available to every member in due course.

Mr. L. H. Nesbitt's resignation as Treasurer was accepted with regret, and after Mr. Nesbitt had been thanked for his past services, Mr. B. Mitchell was unanimously elected Treasurer for the ensuing year. Other appointments were Mr. E. H. Tredwell's reelection as Chairman, Mr. M. Archer's as Vice-Chairman, and Messrs. G. Hilton, W. Ogilvie and L. Selman were appointed to fill vacancies on the Committee.

A very successful meeting concluded with a vote of thanks to the Chairman, the Secretary, and the Committee, submitted by Mr. Green and carried unanimously.
